## Derby Public Art Implementation Plan from 1 April 2004

Preparation of this Implementation Plan is an 'Action' within the Derby Community Strategy Action Plan 2004/5 (Cultural City p.54 3c1). The Implementation Plan was reported to, and endorsed by, the Cultural City Executive at its meeting on 23 June 2004.

Tasks are presented under two sub-headings. Part 1 focuses on 'doing things on the ground'. Part 2 is about setting the scene to help make things happen on the ground; publicising the city's public art and public art opportunities; facilitating the interpretation of public art; assembling and maintaining an effective information base about public art in Derby, and helping to develop the role of public art in environmental education.
