## Children targets of quarter of robberies

CHILDREN under 16 were the victims of a quarter of robberies reported in Bristol over the past seven months, the Evening Post can reveal.

A new wave of crime is seeing youngsters targeted by gangs of teenagers for the latest fashion accessories or gadgets such as iPod music players, state-of-the-art mobile phones or designer sunglasses

Leading police officers in the city say they are becoming increasingly concerned about the growing

trend.
Gangs of boys and girls, some as young as 12, have been targeting parks and other areas popular with youngsters, robbing other teenagers for the "must-have"

As the picture on our front page shows, some teenagers can leave the house with more than £1,000 of accessories on

Police say those who take their MP3 players and mobile phones with them, wear designer gear or ride expensive top-of-the-range mountain bikes inadvertently make themselves a target for

Officers have told the Evening Post that many of these items are then sold door-to-door on many of the city's estates, including Southmead, Hartcliffe, Withywood, Knowle West and

Withywood, Anowle West and Shirehampton.

At the height of Bristol's street robbery problems three years ago, the crime was largely driven by drug addicts needing cash to score their next fix

In 2002, there were about 120 robberies every week. And while many robberies are still carried out by drug addicts, there are now just under 30 robberies a week on

under 30 robberies a week on average following a major crackdown. Since April this year, there have been 972 reported robberies in Bristol – around

rooberies in Bristol – around four every day.

About a third of these have been so-called child-on-child robberies involving under-18s, with just under one in four involving children under 16.

One 13-year-old girl, who cannot be named for legal reasons, has recently been

reasons, has recently been charged with carrying out 14 robberies on youngsters in

Redland. Parks in Redland and Fishponds have become the biggest problem areas for the

Police today issued a ronce today issued a warning to teenager a hat they would prosecute everyone who was in a gang which targeted youngsters, even if only one or two of them actually carried out the robbers.

All gang members present at the scene can be charged with robbery as their presence is helping to intimidate the victim.


Parents were also urged not to allow their youngster to go out with expensive fashion accessories.

AN attempt to cancel a controversial £280,000 public artwork planned for the centre Weston-super-Mare has

ended in failure. North Somerset councillor Mike Bell last night called on his fellow members to ask the executive to reverse the decision to proceed with the Silica scheme on Big Lamp Cor-ner, dubbed "the carrot on the cor-ner" by its critics. by its critics.

But only six supported him and the vast majority of councillors voted against his proposal.

Mr Bell, a Liberal Democrat member for the Weston West ward, presented a 589-name petition which he collected on his personal website opposing the 26-metre high illuminated spire at the start of the full council meeting.

When the time came for his motion to be debated, he described the sculpture as a waste of money.

Weston. The sooner we can get it up
the better and we can appreciate
just what it is. If it continues to be
controversial, so be it."

Tory group leader, Councillor Mike Roe (Weston Clarence and

Uphill), said the whole council had

Uphill), said the whole council had approved the principle of public art at Big Lamp Corner and that it should be chosen by a working group made up of councillors, business people and representatives from the local arts scene.

He said that if it scrapped Silica, the council would lose credibility from other potential investors and plans to regenerate Weston "may go down the pan". He added: "We make decisions as a council and we should stick to them."

Councillor Peter Kehoe (Lib Dem, Yatton), the executive member for

Councillor Peter Kehoe (Lib Dem, Yatton), the executive member for Children's services, said: "We mustn't chicken out."
Silica, which will include a bus shelter and retail kiosk, will stand at the junction of High Street, Regent Street and Meadow Street and should be in place by March.
It was designed by Nottinghambased artists Wolfgang and Heron and is being funded through various bodies including the South West Regional Development Agency, the Weston Regeneration Partnership, North Somerset and Weston Town councils and Weston Townism.

Fisher, 60, and his 53-year-old wife Carol were blows to the head with a blunt instrument such as a lump hammer or sledgehammer, the jury was told.

The Bonfire Night killings The Bontine Night killings happened as the couple were about to sit down to an evening meal in front of the television in their cluttered bungalow.

Mr Fisher was found on the floor of the kitchen in his blood-spattered home, on the 489 near Wadebuidge,
